Call to Order

1. The meeting was called to order at 5:20 p.m.

Approval of Agenda

2. Committee agreed to amend the agenda to defer item 4 – Approval of CAB Minutes – June 12, 2019 to the next meeting.

Disclosure of Pecuniary Interest

4. There were no disclosures of pecuniary interest.

Update on Reaching Home Funding

- 5. Administration noted that, as previously announced, the Federal Government has confirmed that the City of Yellowknife will be the Community Entity until the end of the Reaching Home program in 2024. The five year agreement stipulates \$1,145,590.00 funding for each year. Administration further noted that the Community Entity was granted an additional funding for the Community Capacity and Innovation (CCI) funding designed to support investments towards the design and implementation of Coordinated Access. The CCI funds will be distributed as follows:
 - a. 2019/2020 \$71,180.00
 - b. 2020/2021 \$61,180.00
 - c. 2021/2022 \$61,180.00
 - d. 2022/2023 \$56,680.00
 - e. 2023/2024 \$56,680.00

Administration further noted that for the 2019/2020 fiscal year the Reaching Home program currently has \$311,920.00 of unallocated funds that need to be spent by March 31, 2020.

Discuss Reaching Home Community Plan

- 6. Administration noted that a handout was given to members in the last meeting showing some options of projects based on the Reaching Home Directives. The projects presented were:
 - a. Community Capacity Building,
 - b. Indigenous Healing Services,
 - c. Indigenous Case Management Services,
 - d. Yellowknife Coordinated Access Plan,
 - e. 2020 PiT Count Coordination and Coordinated Access Assistant,
 - f. 2020 PiT Count,
 - g. Transitional Housing, and
 - h. Permanent Support Housing,

Administration requested that Committee reviewed the suggested projects and reached out to other organizations in their sector to find out the need of services and projects in the community. Some of the suggested ideas are to fund:

- a. The remaining month that Side Door wasn't funded in the fiscal year 2019/2020 about \$15,152.00,
- b. Hopes Haven mortgage about \$115,000.00
- c. A Housing First navigator,
- d. Transitional/permanent housing,
- e. Create skills development programs,
- f. The new building upgrades for YWCA transitional housing,
- g. A person with lived and street experience to assist with connecting people to services,
- h. A street level Coordinated Access Centre to help with resumes, counseling and coordinated services, and Create more resources to help people with addictions and mental health
- i. Create an Indigenous Case Management Program run by an indigenous organization.

Committee discussed the 2020 PiT Count and decided that Administration would touch base with the Bureau of Statistics to work with them in order to minimize costs. Committee further decided that the CCI minimum funding of 6% should be used towards the 2020 PiT Count.

 - B. Denning seconded,

That up to \$65,000.00 be spent on a Housing First Navigator geared towards youth and families and that up to \$57,385.00 to be spent on a Housing First Navigator.

That the investment plan for the Community plan be in accordance with the suggested percentages:

50% Housing Services

15% Prevention and Shelter Diversion

10% Support Services

6% Capital Investments

6% Coordinated Access

13% Administration
