- 6. Administration provided an update regarding the proposed schedule for online training:
 - Upload two 90 minute sessions on or before July 9 with 30 day access;
 - Upload two 90 minute sessions on or before July 16 with 30 day access;
 - Upload two 90 minute sessions on or before July 23 with 30 day access; and
 - Host two 90 minute live sessions via Zoom from 10:30 a.m. to 12:00 p.m. and 1:00 p.m. to 2:30 p.m. Sessions could be recorded and accessible for 30 days. A Facebook Live event is being considered for the community session.

Reaching Home COVID-19 Funding Update

- a. Arctic Indigenous Wellness Foundation withdrew their application for COVID-19 Funding;
- b. SideDoor requested \$21,000 to cover staff wages. J. Saturnino noted that a Career Development Officer from Education, Culture and Employment will reach out to I. Notley from SideDoor to discuss other Federal Funding Agreements to address their wage funding request; and
- c. NWT Disabilities Council requested \$5,000 for uniforms.
