<u>Summary of Heritage Committee/Yellowknife Community Foundation Fund Canada 150 Working Group</u>

5. Committee noted that the working group comprised of Mr. David Finch, Eli Purchase, Mr. Mike Vaydik, Mr. Dan Daniels and City Administration met on July 13, 2016. Committee further noted that it was clarified that the funding breakdown is: City 50%; Yellowknife Community Foundation 25%; Canada 150 25%. Committee stated that all working group decisions must be confirmed by the Heritage Committee. Committee further stated that the following project were discussed:

Projects discussed	Notes
Remainder of funding for Terry Pamplin's mural	50% (\$5,500) already committed by HC. Administration will provide forms to the applicant for remainder of funds from Can150/YCF
Statues of important/interesting historical figures in public places (eg. bronze on benches)	No follow up. Champion needed.
Complete repair and installation of John Sabourin Raven sculpture	Administration will discuss with the artist

Committee advised that Administration will prepare a Call for Proposals for projects from other Yellowknifers. Committee further advised that the suggested broad theme is "People, Places, Things". Committee noted that typically they receive applications for Heritage Committee Project Funding twice a year in May and November and that they would review Canada 150 Project applications in November.

Tale of Town Status

9. Committee noted that Ms. Lisa Marie diLiberto and her husband Mr. Charles Ketchabaw, Directors of a Tale of Town, a national theater and media initiative, will be in town in September/October to gather and share main street stories, leading up to Canada's 150th anniversary in 2017. Committee further noted that they are looking for accommodation.

Action: Committee to reach out to independent business owners, local heroes, community stakeholders, and neighbourhood residents that can provide stories.

Designation of the Sacred Tree as Heritage Resource

10. Administration advised that they are working with Mr. Sangris and GNWT, Department of Transportation regarding designation of Sacred Tree as Heritage Resources.

Back Bay Cemetery

11. Administration advised the Back Bay Cemetery site is of archeological, cultural, spiritual or other significance to YKDFN and that Mr. Sangris will research and provide some historic facts to be used on the plaque.

Action: That Mr. Sangris provides information for a plaque on Back Bay Cemetery

13. Committee noted that dates and details regarding costs and fees for artists will be finalized first week of August and that Call to Artist would be issued after that.
